

# Heritage High School Summer School Options 2020

## **1. HHS Gradpoint Summer School – No Cost (Credit Recovery Only)**

Location: Remote Learning Summer School, (July 7 – August 5) - Registration begins June 10.

## **2. North Carolina Virtual Public School (NCVPS)- No Cost: First Time Credit**

Location: Remote Learning, (July 7 – August 17), Registration begins May 1 (July 13 is last day to add a course!) Students approved for enrollment will receive email with username and password at least one week prior to July 7.

WCPSS Considerations for NCVPS Summer Study:

- First time credit will be approved on a limited basis during the summer, and only after consultation with the school counselor and approval of the principal. These opportunities should support the specific graduation plan for the student.
- The course is not offered at the student's base school (Heritage High School).
- Although it is not explicitly prohibited, if a student does not need two courses to get back on grade-level cohort, summer courses should be limited to one course as recommended by the NCVPS Summer Guide.
- Rising 9th grade students wishing to take online courses must secure high school permission through the completion of the NCVPS Course Enrollment Form, to be signed by the high school principal. These students will take the EOC, NCFE, or CTE Post-Assessments at their high school. These requests will be approved by principals on a limited basis according to individual student circumstances.
- GradPoint should be used as the primary option for credit recovery. NCVPS should be used for credit recovery only in extenuating circumstances AND with district approval.
- Must have passed all previous NCVPS courses taken.
- Be self-motivated and an independent learner
- Be computer literate and have easy access to computers and internet

## **3. Dual Enrollment**

WCPSS Dual Enrollment form must be completed.
